Bidding will be conducted through the National Competitive Bidding (NCB) Procedures specified in the Government of Jamaica procurement policies.

Bidders must submit their bids in accordance with the instructions and requirements stipulated in the Standard Bidding Document.

Completed, Stamped and Signed Bid Submission Form (**Bid sum must be inclusive of GCT and shall be clearly differentiated from subtotal amount**).
