PROCUREMENT OF PERSONAL WATER-BASED LUBRICANTS

Ministry of Health & Wellness now invites bids from eligible and qualified companies to supply personal water-based lubricants.

Bidding will be conducted through the National Competitive Bidding (NCB) Procedures specified in the Government of Jamaica procurement policies.

Eligibility Requirements: -

Bidders must submit the following with their bids at the time of bid submission:

- A copy of a valid Tax Compliance Certificate (TCC) or a Valid Tax Compliance Letter (TCL)
- A copy of a valid Public Procurement Commission (formerly National Contracts Commission) Registration Certificate
- Completed, Stamped and Signed Bid Submission Form (Bid sum must be inclusive of GCT and shall be clearly differentiated from subtotal amount).

All other instructions and requirements will be in the bid document. Tender submissions that do not comply with all the above requirements will be deemed non-responsive.
